An automatic adjustment of 5% or 10% can be approved without providing additional information about your request. An amount over 10% reduction requires approval by the dues adjustment committee. Feel free to provide any additional information that you think may help the Dues Adjustment Committee evaluate your request. We trust members to be honest and we pledge not to invade their privacy; and they pledge to accept an adjustment with the understanding that (hopefully) the adjustment is temporary and that we must all do what we can to keep the synagogue healthy for all of its members. Annually you will be

required to reapply for the adjustment that is granted to you on a temporary basis to assist in your time of need. Dues adjustments are intended to be temporary and will be revisited by the Finance Committee semiannually. In the spirit of community, we hope that today's adjustment recipients will someday be in a position to assist others in need of similar temporary assistance.
